RESOLUTION OF THE NEW JERSEY CASINO CONTROL COMMISSION IN THE MATTER OF THE POSSESSION AND DISPLAY OF SLOT MACHINES BY DOUBLE D GAMING, INC.

WHEREAS, Double D Gaming, Inc. (DD Gaming) presently holds a Commission permit to store slot machines and is an applicant for a gaming-related casino service industry license; and

WHEREAS, DD Gaming converts the stored slot machines to "amusement devices," which are then submitted to the New Jersey Legalized Games of Chance Commission (LGC) for testing and approval, for ultimate use at LGC-approved "Casino Nights" and other LGC-approved locations; and

WHEREAS, DD Gaming wishes to exhibit and demonstrate four of its devices at the New Jersey Amusement Association Show being held at Trump Marina on March 1 and 2, 2006, and has requested permission to possess and display these devices at the above trade show; and

WHEREAS, one such device has been approved by the LGC, and the remaining three devices have been submitted to but not yet approved by the LGC, which now has authority over the devices; and

WHEREAS, the LGC has indicated that it does permit unapproved prototypes of amusement devices to be displayed at such trade shows, provided that the devices have been previously submitted to the LGC for review, and that such unapproved devices cannot be sold, delivered or used until final LGC approval is obtained; and

WHEREAS, a slot machine generally remains a "slot machine" under the Casino Control Act and under the Commission's jurisdiction, even



if disassembled or modified in some fashion, unless and until it is decommissioned or approved by another agency for another purpose; and

WHEREAS, the Commission has determined that with regard to the conversion of a slot machine to an "amusement device," the foregoing policy should be modified in this particular instance to provide that once a converted slot machine has been submitted to and accepted by the LGC for review as an "amusement device," it is no longer within the Commission's jurisdiction (unless the device is subsequently rejected by the LGC), and thus no Commission permit pursuant to N.J.A.C. 19:46-1.22 would be required to display the converted slot machines at the amusement device trade show; and

WHEREAS, the Division of Gaming Enforcement has indicated that it does not object to the foregoing arrangement; and

WHEREAS, on March 1, 2006, the Commission received all information and took final action in this matter;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Casino Control Commission by a 4-1 vote (Commissioner Epps dissenting) that no Commission permit pursuant to N.J.A.C. 19:46-1.22 is required for DD Gaming to display its converted slot machines/unapproved prototype amusement devices at the New Jersey Amusement Association Show being held at Trump Marina on March 1 and 2, 2006, since they have been submitted to and accepted by the LGC for review, and are no longer
